#### Ordinances

Steve Uffelman moves to read Ordinance number 1154 by title only. Motion carries, all in favor. Steve Uffleman moves to approve Ordinance 1154, seconded by Jack Seley. Motion carries, all in favor. This ordinance modifies section 30.08 of the Code of Prineville. This allows for minute meetings to be recorded by sound, and to be accompanied by a written meeting brief, which shall include a summary of topics discussed, members of the governing body present, and the results of all votes and the vote of each member by name. This meeting brief will be provided to each council member.

## Resolutions

Resolution 1084, a resolution repealing Resolutions 1001, 708.

Staff report from City Attorney Carl Dutli: Resolution 708 was originally written to establish the City Council as a local contract review board. That ordinance was updated in 2003 to bring the city in line with Oregon law. At that time, there was not language in resolution 1001 that specifically repealed resolution 708, only by inference. When resolution 1070 was considered to amend public contracting regulations, a section 14 was added, but was not included on the copy signed. Resolution is a housekeeping measure to repeal the outdated resolutions 1001 and 708. Steve Uffelman moves to read resolution 1084 by title only, seconded by Steve Ilk. Motion carries, all in favor.
