Consent Agenda

Councilor Roppe made a motion to approve Consent Agenda. Motion seconded. No discussion. All in favor, motion carried.

Visitors, Appearances and Requests:

- A. Captain Boyd introduced Jessica Bridgeman along with back ground of what was required of Ms. Bridgeman to become a Reserve Officer. Steve Forrester, City Manager performed the swearing in of Reserve Officer Jessica Bridgeman.
- B. Frank Profily and Dorless Reid of the Airport Commission handed out Prineville Airport month of April financial statements to the Council.
- C. Scott Aycock, representative for Cascade East Transit (CET) provided a brief overview of what had been previously presented to the Council. Mr. Aycock then introduced a number of individuals both passengers and employees to speak on behalf of the service they receive in Prineville from CET.
- D. Mr. Presley, General Manager of Econo Lodge in Prineville expressed concerns of a temporary liquor license approved for Cinnabar/John Dough's Pizza to have an

A. Airport Commission - Contribution FY 09/10

B. CET – Contribution FY 09/10

There were discussions regarding both of these items and how to split the transportation funds set aside for a contribution between Airport Commission and Cascade East Transit.

Councilor MacDonald made a motion to contribute \$7,500 each to the Airport Commission and to Cascade East Transit. Motion seconded. All in favor, motion carried.

C. APHIS Funding – Revisit

County Commissioner Fahlgren presented the background information of this organization and the type of service they have provided to the City of Prineville and Crook County to mitigate wildlife issues.

Councilors agreed to postpone a decision on this contribution until the June 23, 2009 Council meeting.

D. Cattle Drive - Round Up Rodeo

Councilor Noyes provided an update regarding the meeting the City had with the Round Up Rodeo board and the solutions they agreed upon to manage the cattle this year.
