A. Managers Report - Steve Forrester

A. Ordinance No. 1173 – An Ordinance Regarding Vehicle Inventory Policy (First and Second Emergency Reading) - Carl Dutli / Chief Bush

Councilor Noyes made a motion to read Ordinance No. 1173 by title only. Motion seconded. No discussion on motion. All in favor, motion carried.

Chief Bush provided the reason for the ordinance. He stated that since the existing ordinance was found as unconstitutionally vague, the Police Department was not able to impound vehicles. The Police Department policy is determined to be constitutional; however the Ordinance is what is looked at. The proposed ordinance would reconcile it with the policy. Carl Dutli, City Attorney gave additional information.

There were discussions regarding whether or not is necessary to have both readings as an emergency; that the Police Department has not been able to impound vehicles for the last twenty days which could allow repeat offenders of driving while suspended, or not having insurance, etc. to leave with the vehicle; and how impounds are handled in regards to making an inventory list of the vehicle and its contents.
