City Council Meeting Brief October 11th, 2011

Additions to the Agenda

Discussion of Mark Matheson's TAG project under Council Business Item "C".

Consent Agenda

Councilor Gillespie made a motion to approve Consent Agenda as presented. Motion seconded. All in favor, motion carried.

No one came forward.

Council Business:

A. Consideration of Enterprise Zone Amendment for Vitesse, LLC

Carl Dutli, City Attorney and Steve Forrester provided the background information for the amendment.

Councilor Noyes made a motion to approve amendment to enterprise zone. Motion seconded. No discussion on motion. All in favor, motion carried.

B. Proclamation to Recognize October as National Domestic Violence Awareness Month – Councilor Seley

Councilor Seley read the request for proclamation and felt that endorsement should be approved.

Councilor Seley made a motion to approve endorsement of proclamation recognizing October as National Domestic Violence Awareness month. Motion seconded. No discussion on motion. All in favor, motion carried.

C. Discussion of TAG project

Councilor Seley said he felt it would be ill advised to enter into an agreement like this at this time.

Councilor Merritt said that she is not comfortable with this and that there isn't enough information.

Councilor Beebe isn't comfortable with this yet either and would like to see more information before hand.

Councilor Gillespie isn't interested at this time.

Councilor Noyes feels EDCO is a great resource for this and is why we support EDCO. It should be the Chief or Sheriff that brings this to Council if they support once Mark Matheson has gone through EDCO.

Staff Reports:

A. Managers Report - Steve Forrester

Steve Forrester stated that: Legislative work continues with strategy for HB and will be coming up with a senate version; Mayor Roppe, OID and Eric Klann will be traveling to DC next week to work with the different interior departments; Project Maverick is doing due diligence on property purchase deal; Project Cloud representatives came to town and is looking for property to suit their needs; he has handed out a written airport update; and today is Mary Puddy's birthday.
