Re: Ordinance 1188 – OR Highway 126 Corridor Facilities Plan

Ordinance 1188 is the implementing ordinance for the adoption of the OR Highway 126 Corridor Facility Plan, which was presented to City Council in a joint public hearing with the County Court on December 14, 2011. At that meeting, the governing bodies agreed to move forward with separate ordinances at their next respective meetings in January.

As no changes were proposed to the document at the joint public hearing, we are not including the full 142-page document in each of the Council member packets but instead ask you to refer to the document you received prior to the December 14 meeting. If any Councilor does need a new copy, the Planning Department will be glad to provide it.

After the first reading is passed, a full copy of the finalized plan will be included as Exhibit A with the ordinance at the second reading. This copy will only be included in Mayor Roppe's packet unless other Councilors request to receive a full copy as well.

ORDINANCE NO. 1188

AN ORDINANCE AMENDING THE PRINEVILLE COMPREHENSIVE PLAN TO ADOPT, BY REFERENCE, THE OREGON HIGHWAY 126 CORRIDOR FACILITY PLAN AS AN UPDATE TO THE CITY OF PRINEVILLE TRANSPORTATION SYSTEMS PLAN

WHEREAS, the City of Prineville adopted the most recent update of the City of Prineville Transportation Systems Plan (TSP) in 2005, and;

WHEREAS, the City of Prineville and Crook County have worked together with the Oregon Department of Transportation (ODOT) to prepare the OR Highway 126 Corridor Facility Plan as an update to the TSP, and;

WHEREAS, the contents of this TSP update are guided by Oregon Revised Statute (ORS) 197.712 and the Department of Land Conservation and Development (DLCD) administrative rule known as the Transportation Planning Rule (TPR), OAR 660 Division 12, and;

WHEREAS, the City of Prineville, in cooperation with Crook County and ODOT, has conducted a comprehensive public involvement process for the development of the OR Highway 126 Corridor Facility Plan including a series of technical advisory committee meetings, project advisory committee meetings spanning from December 15, 2010, through August 23, 2011, and;

WHEREAS, the City of Prineville and Crook County published proper public and agency hearing notice as required by Prineville City Code, Crook County Code and Oregon State Law; and

WHEREAS, the City of Prineville Planning Commission held a joint public hearing with the Crook County Planning Commission on November 15, 2011, and, after consideration of public testimony and the whole record, the Prineville Planning Commission voted 6-1 to recommend the OR Highway 126 Corridor Facility Plan (Exhibit A) to be approved by the Prineville City Council;

**NOW, THEREFORE, THE PEOPLE OF THE CITY OF PRINEVILLE
ORDAIN AS FOLLOWS:**

Exhibit A, the OR Highway 126 Corridor Facility Plan is hereby adopted and incorporated into the City of Prineville Transportation Systems Plan by reference, thereby amending the City of Prineville Comprehensive Plan.
