Staff Reports:

A. Managers Report – Steve Forrester

Mr. Forrester stated that: Jason Carr, Bill Zalenka, and himself were invited to speak at AOC which was well received; there will be a Fly-In breakfast at the airport for Father's Day; the Police Department assisted in the rehabilitation of the shooting range; a renewable energy company is in dialogue with the city; the TSP kick-off meeting tomorrow; the Wetland kick-off meeting was held today.

Eric Klann, City Engineer came forward and provided an update for the Wetland kick-off meeting.

Mr. Forrester continued with announcing there is an EDCO annual luncheon tomorrow, the Deschutes River Conservancy Board meeting is this Friday at the library; Central Oregon Cities Organization meeting Monday; the seal coat project bid came in at \$34,000 and the water line replacement came in at \$16,000.

B. Ordinance No. 1192 – An Ordinance Establishing a Franchise Agreement with Prinetime (First Reading) – James Wilson

There were questions regarding balance of all franchise agreements regarding services provided in lieu of franchise fees, how the lines were going to be installed, appearance on existing Pacific Power poles, and if it would provide more competition for the service.
