Staff Reports:

A. Managers Report - Steve Forrester

Mr. Forrester stated: the waterline project is underway and will be completed well before the school year begins; Oregon Senate is working on companion bill to HB 2060, there has been ongoing discussion with Senator Merkley's office that appear to be motivated for the companion bill; Don Wood submitted his resignation from the

Planning Commission leaving a vacancy; there will be a joint City Council and County Court meeting on August 1st at 2:00 PM to review the UGB adjustment; the League of Oregon Cities Conference is coming up, please let Lisa Morgan know if you plan to attend; the Health Fair was a success with over 100 participants attending; and the horse races begin tomorrow night.

B. Meadow Lakes Update - Zach Lampert

Zach Lampert, Head Golf Professional provided the Council with an update that included: the facility capital projects progress; landscaping improvements; the 4th of July events; equipment upgrades; extra promotion efforts; and the many tournaments during the summer.

C. Airport Update - Kelly Coffelt

Kelly Coffelt, Airport Manager provided the Council with a written update for the last six months that included: working on future helipad with the Forest Service; fuel sales are up 22%, keeping in mind that the largest months for fuel sales is August and September; hangar vacancies are down to 5 or 6 single hangars, all others are full; there is a hanger under construction and interest in airport continues; fuel quality has had definite improvements made; a budget for the airport has been created; an advisory committee has been formed; events are being created to bring more attention to the airport; and the Father's Day breakfast served over 120 meals.

Future goals for the airport include: continue working on Airport Master Plan; continue helibase efforts; and continue improving customer service.
