A. Intent to Award Airport Well Bid - Eric Klann

Eric Klann, Public Works Director presented the staff report.

Councilor Carr made a motion to approve intent to award the 2013 Prineville Airport Water Wells Construction Project Bid to Western Water Development. Motion seconded. No discussion on motion. All in favor, motion carried.

A. Managers Report – Steve Forrester

Mr. Forrester stated: James Wilson, IT Director was successful in obtaining a Homeland Security grant; the slurry project is scheduled for next weekend and will be restriped; the waterline extension project is completed on time and under budget; the airport is pleased to announce that August was a record breaking month in fuel sales; we may be contacting Council regarding cancellation of the September 24th Council meeting since there is no business scheduled; and provided a pension obligation bond update, that may require that a special Council meeting to be held.

Mayor Roppe read a thank you note received from the Mayor of Altuna following his visit to Prineville.

B. Quarterly Financial Report – Liz Schuette

Liz Schuette, Finance Director read some highlights of recent correspondence from Standard & Poor's that noted the city's strong financial management.
