Request to Lawfully Dispose of Firearms

#### **REQUESTED ACTION:**

The Police Department requests permission to sell or trade surplus firearms and to send others off for destruction in accordance with Ordinance Section 33.23.

#### **BACKGROUND:**

The Prineville Police Department takes in numerous guns each year. Some are given to the Department by citizens who no longer wish to have them. Some are seized as evidence or turned over as found property. Each firearm is subsequently inspected to determine if it has sporting or collector value, is safe to use and does not fall into a prohibited class (sawed off rifle or shotgun, serial number removed etc.) Firearms deemed unsafe or in a prohibited class are slated for destruction. The remaining safe and legal firearms are pooled until a sufficient number are ready for legal sale to a Federal Firearms Dealer, who will sell them to only legally qualified citizens.

Firearms for destruction are transferred to a Federal Firearms Dealer for destruction. These firearms have some value to the dealer as they can harvest small parts to use on customers' firearms needing the often obsolete parts.

Firearms for sale will be offered to both local and regional Federal Firearms dealers. We generally seek to trade the firearms for needed equipment or replacement "duty" firearms.

#### **FISCAL IMPACT:**

We hope to use proceeds from this trade/sale to update our well-worn duty handguns. This could represent a savings to the City of one to two thousand dollars. We will have to see what bids are offered to get a final savings.

**RECOMMENDATION:** I request this request be approved.
