#### Additions to the Agenda

#### **Consent Agenda**

Councilor Seley stated on page three (3) of the June 24, 2014 meeting brief that it should state not in favor of reimbursing construction costs for these improvements.

B. Young Life – Jacob Solomon, Area Director

### A. Discussion of League of Oregon Cities (LOC) 2015 Legislative Recommendations – Steve Forrester

Steve Forrester, City Manager stated that copies of the LOC 2015 Legislative Recommendations have been distributed again and that there has not been much input yet. Please review them and return to Lisa Morgan.

#### **Staff Reports:**

#### A. Manager's Report – Steve Forrester

Mr. Forrester stated: the horse races begin tomorrow; please let Lisa know if you plan on attending the LOC annual conference; over 1,000 guests rode the Shay locomotive for the 4<sup>th</sup> of July, with approximately 40% of those guests from out of the area; Crook County Fire and Rescue (CCFR) has agreed to fund two additional dispatch positions; cart paths rehab will begin next Wednesday at Meadow Lakes; the airport had another master plan update meeting; the wetland project will go before Crook County Planning Commission for its third and hopefully last meeting for approval; July 22<sup>nd</sup> the city and county will have a joint work session on the jail feasibility study; and the wetland project was selected as a top 5 project with the Oregon State Parks and Recreation Department, and with Eric Klann's presentation received \$260,000 for the project.

## A. Ordinance No. 1206 – Changing the Name of Crestview Road to Crestview Lane (PUBLIC HEARING) (SECOND READING)
