### Brief Description of Proposed Use:

In November of 2016 the citizens of Crook County approved a bond measure for the construction of a much needed new Crook County Jail. This application requests approval for a Conditional Use Permit and Design Review for the Crook County Public Safety Facility. The facility includes the existing 3,900 SF Sheriff's office and the addition of a 31,200 SF Jail Facility containing inmate housing (76 beds), administrative offices, booking, medical, laundry and kitchen facilities.




