## Additions to the Agenda

#### Consent Agenda

Councilor Seley made a motion to approve Consent Agenda. Motion seconded. All in favor, motion carried.

#### Visitors, Appearances and Requests:

A. Roger Harris – VP of Cable Operations – Crestview

Mr. Harris gave the Council an update on their operations, stating that they are upgrading their system allowing a higher level of service.

- C. Ellen Krider, Attorney for Prinetime came forward regarding an ordinance that would establish a Privilege tax.

#### **Council Business:**

#### A. Request for Planning Fee Waiver

Scott Edelman, Senior Planner presented the staff report.

Tim Deboot came forward with handouts for Council on the proposed Open Campus building. He stated that this is a community project and OSU is a partner. They were successful in getting a 3.9 million dollar grant that is making this possible. He added that working with City staff has been wonderful.

Councilor Seley made a motion to pay the Planning fees from the Council fund. Motion seconded. There was discussion on motion. All in favor, motion carried.

#### B. Utility Assistance Program Agreement

Carl Dutli, City Attorney provided the background information for this agreement.

Councilor Roppe made a motion approving the agreement between the City and St. Vincent DePaul. Motion seconded. No discussion on motion. All in favor, motion carried.

#### A. Managers Report – Steve Forrester

Steve Forrester stated that: Councilor Noyes, Roppe and MacDonald along with staff were able to meet with Senator Wyden's office; communications continue with HM3 for possibly locating at the Freight Depot; had the 90% meeting with Anderson Perry regarding updating the Wastewater Facility Plan which would provide an opportunity to stabilize sewer rates for the future as well as being more competitive with other cities rates; Toby Van Altvorst is at a shortline convention with opportunities of more exposure for the Freight Depot; and Deschutes Water Alliance will be having an election of officers next Tuesday with Jeff Merkley as a guess speaker.
