A. Consideration of Possible Contribution to Crook County Kids Club -

Councilor Merritt is thinking a \$1,500 contribution.

Councilor Seley made a motion to contribute \$1,500 to the Crook County Kids Club. Motion seconded. No discussion on motion. All in favor, motion carried.

Staff Reports:

A. Managers Report - Steve Forrester

Steve Forrester stated that: the city engineer has informed him that the city has received a OWEB grant for approximately \$200,000 that will help fund the build out of the wetlands; the city is moving forward to recruit for a Public Works Superintendent and Councilor Seley will sit in on the selection committee; the city and HM3 have meetings scheduled for later this week; the city, county, Warm Springs Confederated Tribes had met regarding the federal legislation (Walden HB 2060), and is in the House of Representatives. It will hopefully get passed into law prior to end of the year.

Mr. Forrester asked Officer Burton and Chief Bush to come forward. Mr. Forrester passed around a letter received regarding the level of professionalism of Officer Burton and that he deserves recognition for this.

Chief Bush added that this is a great example of what right looks like.

Mayor Roppe added to Mr. Forrester's legislative brief and that the Tribes have become real partners in the effort of Walden's bill.

B. 911 Concept Presentation – Chief Bush

Chief Bush presented a power point presentation. The presentation outlined advantages to combining 911 services with three other counties and how doing this would align with the Kimble report for combining 911 services recently adopted at the state level.
