# City Council Meeting Brief June 26, 2012

### **Council Members Present:**

#### Additions to the Agenda

Add George McCart to Visitors and Appearances to talk about ADA sidewalk ramps in town.

#### Consent Agenda

Councilor Merritt made a motion to approve consent agenda as presented. Motion seconded. No discussion on motion. All in favor, motion carried.

### Visitors, Appearances and Requests:

#### A. George McCart

Scott Smith, Street Supervisor came forward to introduce Mr. McCart, explaining how he has been important to prioritize which sidewalks should get ADA ramps from an ADA accessible standpoint.

Mayor Roppe and Councilor Seley thanked Mr. McCart for his efforts in this.

No one else came forward.

#### **Council Business:**

A. Intent to Award 2012 Grind and Inlay Project – Scott Smith Mr. Smith presented the staff report.

Councilor Seley made a motion to approve an intent to award to 7 Peaks Paving, LLC in the amount of \$229,229.29. Motion seconded. No discussion on motion. All in favor, motion carried.

### B. Intent to Award 2012 Water Main Replacement Project - Brian Harmon

Brian Harmon, Public Works Superintendent presented the staff report.

There were no questions.

Councilor Gillespie made a motion to approve the intent to award to Dice Construction for \$130,644.40. Motion seconded. No discussion on motion. All in favor, motion carried.

# C. Status of Humane Society of the Ochocos Agreement - Chief Bush

Chief Bush provided an update on the agreement with Humane Society of the Ochocos. Chief Bush handed out a corrected staff report, which corrected a typo from the staff report in the packet.

Council agreed they would like to have a workshop to further discuss all options for animal control.

### **Staff Reports:**

# A. Managers Report – Steve Forrester

Mr. Forrester asked Chief Bush to provide an update on the Kids Day at the carnival. Chief Bush said that 863 children were present and \$1100 had been raised from the community to help defray the costs of the arm bands. They were also able to give away 66 bicycle helmets during this event.

Mayor Roppe spoke regarding her trip to Salem for the Boys and Girls. Brady Slater was the Governor for this event.

Mr. Forrester asked Council to review the LOC document that was distributed to them to prioritize what they felt were important to follow during the 2013 legislative session; safe routes to school will be going out for proposals; the airport should be receiving Connect Oregon IV funding for the installation of an AWOS and Kelly Coffelt is planning on attending the next Council meeting to provide an airport update.

### **Ordinances:**

A. Ordinance No. 1191 – An Ordinance Amending Ordinance No. 1189 (Second Reading) – Carl Dutli

Carl Dutli, City Attorney did not have anything more to add from the first reading.

Councilor Uffelman made a motion to approve Ordinance No. 1191 for the second reading. Motion Seconded. All in favor, motion carried.

# B. Ordinance No. 1192 – An Ordinance Establishing a Franchise Agreement with Prinetime (Second Reading)

# B. Resolution No. 1190 – Declaring the City of Prineville's Election to Receive State Revenue Sharing (PUBLIC HEARING) – Liz Schuette
