#### A. Managers Report – Steve Forrester

Mr. Forrester stated: That the city has recently received two complimentary comments regarding Meadow Lakes and Pat Goehring and crew; and asked Captain Boyd to come forward for a Public Safety update.

Captain Boyd stated: September is sex offender address verification; and school starts in a few days so please slow down and be careful.

Mr. Forrester continued stating that there is a St. Charles Hospital open house here in the chambers; there is a TSP workshop for Council on September  $10^{th}$  from 4-6 PM; a joint City/County meeting for a UGB expansion is scheduled for September  $4^{th}$  beginning at 10:00 AM; and there is a very light agenda for the September  $24^{th}$  Council meeting and Council may want to consider not having a meeting.

Matt Wiederholt, Railroad Manager and Steve Forrester informed Council of the next phase for marketing the railroad. There were questions.
