A. Jail Lease IGA Amendment – Carl Dutli

Carl Dutli, City Attorney provided the background information for the amendment.

B. Intent to Award Well Abandonment Project – Eric Klann

Eric Klann, Public Works Director explained the process for Department of Human Services (DHS) review of wells. There are four wells to abandon.

Mr. Forrester reported: the jail utility project is almost complete with Mike Kasberger and Pat Goehring working all night on the project; Department of Environmental Quality (DEQ) will be having their council meeting here tomorrow and will be touring the wetlands; Mayor Roppe is in Washington DC and will be attending meetings regarding natural resources in rural America; there is a COACT meeting this Thursday; an Air Quality meeting on September 21st; the council vacancy applications deadline is September 15th; and the Airport Master Plan has been distributed to council.

B. Barnes Butte Property Update – Eric Klann

Mr. Klann provided a power point presentation that highlighted the work that has been done on the property since the purchase, explaining that there is a focus committee that will start exploring ways to get input for plans on the property.

C. Committee Reports

Councilor Papke provided a Governance Committee update along with an anticipated timeline for the draft to get to council.

Councilor Uffelman stated that there was a Railroad Committee meeting last week and is pleased to announce that they are operating in the black, have upgraded a railroad crossing and have new customers.
