RESOLUTION 906

A RESOLUTION DECLARING THE FINAL ASSESSMENTS ON PROPERTY BENEFITTED BY THE PLACEMENT OF SEWER LINES, REPLACEMENT OF WATER LINES, AND RESURFACING STREETS ON REAL PROPERTY IN NORTHRIDGE LOCAL IMPROVEMENT DISTRICT AND DIRECTING THE CITY RECORDER TO ENTER A STATEMENT THEREOF IN THE DOCKET OF CITY LIENS AND IN CROOK COUNTY RECORDS AND TO SERVE NOTICE TO THE ADJACENT BENEFITTED PROPERTY OWNERS.

IT IS HEREBY RESOLVED BY THE CITY OF PRINEVILLE AS FOLLOWS:

i. RECITALS:

A. The City Council did by Resolution No. 854 passed August 24, 1999, declare its intention to Place a sewer line, place a water line, and resurface streets to serve real properties located in Phase I and II of Northridge Subdivision and to assess the cost thereof on each lot or parcel thereof to be benefitted by such improvements, its proportionate share of the costs of said improvements, and did fix the time and place for hearing protests against the construction of said improvements and the assessments and costs thereof.

B. Notice of said hearing was sent by mail to each owner of property in the proposed local improvement district as required by ORS 223.389.

C. A meeting of the City Council was held on September 14, 1999, which was the date and place fixed in said Resolution for the purpose of considering any such protest. The hearing was continued to September 28, 1999, at which time the Council deemed that the construction of said improvements was and is of material benefit to the City and that all property to be assessed thereof will be benefitted thereby, did order the construction of said improvements and formation of the Northridge Local Improvement District by Ordinance # 1072 dated November 9, 1999.

D. The proposed estimated costs of such improvements were established at \$9,460.00 per each lot within Northridge Local Improvement District.

E. Notice of the proposed estimated assessment was mailed to the benefitted property owners as required by Oregon Law, which notice stated the amounts of the proposed estimated assessment and fixed a date by which time objections were to be filed to such estimated assessment.

F. On May 8, 2001, the City Council met to consider any objections to the estimated assessments. After considering comments, questions, and objections, the City Council agreed to adopt the recommended estimated assessment.

G. On May 22, 2001, the City Council passed Resolution # 890 which declared estimated assessments on the property benefitted by the placement of sewer lines, replacement of water lines, and resurfacing streets on real property in Northridge Local Improvement District and directed the City to enter a statement of said estimated assessments in the docket of City Liens in said City and to enter a statement of said liens with the Crook County Clerk's office.

H. Said improvements were constructed and the costs of said improvements including administration costs were in the amount of \$848,579.11.

I. Notice of the proposed final assessments were mailed to the benefitted property owners as required by Oregon law, which notice stated the amounts of the final assessments proposed on each property and fixed a date by which time objections were to be filed.

J. On February 12, 2002, the City Council met to consider any objections to the final assessments. Three letters written by Northridge residents were discussed as well as questions from property owners. Ethel Smith, on behalf of herself and Don Smith, objected to their three lots described as tax assessor's map 141629AC TL 2300, 2400, and 2500 being treated as one and a half equivalent dwelling units. Ethel Smith agreed that she and her husband, Don Smith, would sign a deed restriction to allow only a single-family residence on the three lots if the EDUs were reduced to one lot. Based upon Ethel Smith's representation, the City Council instructed City Staff to prepare this Resolution and spread the assessment among 108 EDUs rather 108.5 as proposed by Staff.

2. It is hereby determined that the proportionate share of the costs of construction of said improvements on each parcel of property benefitted by said improvements is the amount set opposite the description of each piece and parcel of property on Exhibit A attached hereto and by this reference made a part hereof, and that each parcel of land benefitted by the construction of said improvements to the full extent of the amount so set opposite each parcel in that respective amount, represents a proportion benefitted of said improvements to said respective parcel of property, and that Council does hereby declare that each of the parcels of property described on Exhibit A is hereby assessed the amount set opposite each respective description for the costs of construction of said improvements.

3. The total amount assessed for the placement of sewer lines, replacement of water lines, resurfacing streets is \$848,579.11.

4. Assessments are hereby made on the parcels of real property which are located in Crook County, Oregon, and described on the attached Exhibit A for the placement of sewer lines, replacement of water lines to serve said real property and to resurface streets.

5. The recorder of the City of Prineville, Oregon, is hereby directed to enter a statement of said assessments in the docket of City Liens in said City and is hereby directed to serve notice hereof on the property owners of the aforesaid properties by mailing them, within 10 days from the date of this Resolution such notice.

6. The amounts of the assessments described on the attached Exhibit A are due at this time. No interest shall be owing if the full assessment is paid on or before 30 days from the date of this Resolution. However, the owner of any property assessed shall have the right to make application to the City of Prineville to make payments in semi-annual installments over 10 years at 6.25% per annum interest beginning 30 days from the date of this Resolution until paid. Such application shall be made on a form furnished by the City of Prineville and shall be made within 10 days after the above notice is mailed to the property owners.

7. This resolution is effective the date passed by the City Council.
