

RESOLUTION NO. 864

City Of Prineville

A RESOLUTION PROVIDING FOR ADOPTION OF AMERICAN PUBLIC WORKS ASSOCIATION (APWA) OREGON CHAPTER 1990 STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION INCLUDING THE JUNE 1992 SUPPLEMENTALS AND AUGUST 1996 UPDATES.

WHEREAS: There is a commonality of standard specifications for Public Works Projects among Public Works Jurisdictions within the State of Oregon;

AND WHEREAS: The City of Prineville along with many public works jurisdictions and the Oregon Department of Transportation have worked towards development of generic specifications statewide, which in principle are the APWA specifications;

AND WHEREAS: The City of Prineville is in need of broad scope updating of its Standard Specifications and Standard Drawings for Public Works Projects along with Sub-Division technical standards;

AND WHEREAS: APWA Standard Specifications allow flexibility to the City of Prineville Superintendent of Streets, Superintendent of Water and Sewer, City Manager and City Council to provide Special or Supplemental Specifications on a project by project basis, and/or to specify variations as may be appropriate;

AND WHEREAS: APWA Standard Specifications allow flexibility and consistency in utilizing Special Specifications for other State agencies, for aggregate gradations, pavement and concrete products, water, sewer, structural and electrical within the standards of the industry;

AND WHEREAS: APWA Standard Specifications further allow conformance to existing and future requirements and policies of the American's With Disability Act;

AND WHEREAS; Division 1 General Requirements of the Oregon APWA Specifications provide uniformity of contract language which may be adopted as advisory to support the technical specifications of Divisions 2 through 5 and the Standard Drawings, without usurping the City's adopted policies on contract language, management or enforcement;

NOW THEREFORE BE IT RESOLVED BY THE CITY OF PRINEVILLE AS FOLLOWS:


1. The American Public Works Association (APWA) Oregon Chapter 1990 Standard Specifications for Public Works Construction including the June 1992 "Supplement to the Standard Specifications", and the August 1996 "Update to the Standard Specifications" are hereby adopted. Division 1 of the APWA Specifications denoted as General Requirements shall be considered advisory to the City for the purposes of consistency with the remaining Divisions.
2. The City of Prineville directs that the APWA 1990 Standard Specifications for Public Works Constructions as they have or maybe modified in the future shall form the basis of the City's Standard Specifications unless otherwise directed by the City, or as maybe modified by the Superintendent of Streets or, Superintendent of Water and Sewer or their designee, on a project by project basis.
