City Council Meeting Brief September 23, 2008

Additions and Changes to the Agenda

Ordinance No. 1156 removed from agenda and first reading continued to the October 14, 2008 meeting.

Consent Agenda

Motion made to approve September 9, 2008 brief meeting summary as amended. Councilor Roppe made a motion to approve liquor license for Main Street Saloon. Motion seconded, no discussion on motion. Motion carried all in favor.

Visitors, Appearances and Requests:

Jay Porter, President for Chamber of Commerce gave a presentation updating Council on activities the Chamber has been involved in

David Love, Executive Director to Crook County Habitat for Humanity gave a power point presentation. Mr. Love encouraged everyone to get involved in some way.

Council Business:

Dan Lovelady addressed the Council requesting a motion to award the bid to SHW Construction for construction of the freight depot. Councilor Roppe made a motion approving the bid award. Motion seconded. Motion carried all in favor.

Ricky Sites, Community Development Director presented recommendations to fill the Planning Commission vacancies. Those recommended were: Deb Harper, William Van Vactor and Don Wood. Councilor Uffelman made a motion to fill the Planning

Commission vacancies as recommended. Motion seconded. There were discussions regarding the appointments. Motion carried all in favor.

Staff Reports:

Wayne Van Matre, Interim City Manager stated that a Quick Response grant was received to explore the feasibility of shared facilities for BLM and the Forest Service.

Ordinances:

Ordinance # 1157 (1st Reading) regarding housekeeping zone map and comprehensive map amendments to reconcile to each other. Ricky Sites, Community Development Director presented the staff report for the first reading. Councilor Roppe made a motion to read ordinance by title only. Motion was seconded. Motion carried all in favor. There was a brief discussion on motion. The Planning Commission recommended approval of the amendments. Councilor Roppe moved to approve first reading of Ordinance # 1157. Motion seconded. Motion carried all in favor.

There was discussion regarding the resolution and by approving would result in an approximate 20 percent savings. Motion seconded. Motion carried, all in favor for the reading. Councilor Uffelman moved to approve Resolution # 1087. Motion seconded. Motion carried all in favor.

Resolution # 1088 – regarding revision of Community Development fee structure. Councilor Roppe made a motion to read resolution by title only. Motion seconded. Motion carried all in favor. Ricky Sites, Community Development Director presented the staff report. Councilor Roppe moved to approve Resolution # 1088. Motion seconded. No discussions. Motion carried all in favor.

Executive session adjourned at 8:34 PM and regular meeting resumed.
