#### **Consent Agenda**

B. Bike Park Property Request- Darlene Henderson

Steve Forrester summarized the Railroad Commissions position on supporting the Council's decision.

Richard Bonine, Crook County Parks and Recreation Department (CCPRD) Director, stated that the staff and the CCPRD Board can get behind this project and oversee development. Mr. Bonine explained that he has gone through CCPRD owned property logs and they do not have any property that they do not use to trade, however CCPRD is willing to maintain and carry insurance.

Councilor Noyes said that language could be added that could protect the city if anyone ever did want to buy the property in the future.

Seth Crawford, a supporter of the project explained that the full grant application to help fund this park is due October 10, 2014.

Council agreed to have an intergovernmental agreement to lease the property will be brought back to the next council meeting.

### A. Review of League of Oregon Cities (LOC) 2015 Legislative Recommendations - Steve Forrester

Steve Forrester, City Manager referred to the memo distributed that highlighted the results of council and staff's priorities. They were as follows: Pass a comprehensive transportation funding and policy package; continue or enhanced funding for ConnectOregon; clarify and enhance medical marijuana dispensary regulations; and support efforts and program funding to address Oregon's long term water supply needs including recapitalization of the Water Conservation, Reuse and Storage grant program and implementation of a place-based pilot program for local water resources planning.

Council agreed with the recommendations.

#### A. Manager's Report – Steve Forrester

Mr. Forrester asked Scott Smith, Street Supervisor to provide an update.

Mr. Smith stated that ODOT's paving project will begin this Sunday evening and three (3) weeks from now the ADA ramp upgrades will begin.

Mr. Forrester stated: the League of Oregon Cities conference is coming up; the wetland project received approval from the Crook County Planning Commission; Kelly Coffelt, Airport Manager reported that a property agreement has been reached with Hillsboro Aviation to move forward with student housing; the 3<sup>rd</sup> annual Fly-In is this weekend at the airport; and July is shaping up to be a good month for the railroad.
