



# CITY OF PRINEVILLE IRRIGATION SYSTEM REBATES

The City of Prineville is offering rebates on irrigation system add-ons (while funds last) that can help you reduce your outdoor water use.

## ELIGIBILITY REQUIREMENTS

- You must be a single-family residential customer with an active water account in good standing with the City of Prineville's Utility Billing Department.
- Your irrigation system must have a backflow prevention device, tested annually by a state-certified backflow assembly tester. The City of Prineville will review your most recent backflow test to confirm your eligibility.
- You will need to submit a completed rebate form along with a copy of the proof of purchase for the item within 30 days of the item purchase date.
- The City of Prineville will conduct an inspection of your irrigation system before a rebate is administered to ensure that the rebate item has been installed correctly.
- If you are a renter, you will need to have the property owner's signature of approval.

Rebate Item	Rebate Amount
<b>Weather-based irrigation controller</b> Adjusts watering based on local weather and landscape conditions	Up to \$100
<b>Rotating sprinkler nozzles</b> Uses less water and reduces runoff compared to traditional sprayers	\$4 per nozzle (up to 20 nozzles)
<b>Soil moisture sensor</b> Turns irrigation off when moisture near roots of plants is sufficient	Up to \$50

## REBATE PROCESS:

1

### Purchase and install your qualifying rebate item

Choose your irrigation system add-on from the City's list of approved devices (see page 3).

2

### Complete and submit this rebate form within 30 days of item purchase

Mail, drop off, or email the completed and signed form with a copy of your proof of purchase. After your eligibility is confirmed, the City will call you to set up an inspection appointment. Questions? Call 541.447.5627

### Receive your rebate

If your system passes inspection, you are eligible to receive your rebate! Your rebate will be processed within 60 days of your inspection and will appear as a credit to your water account.

## REBATE AGREEMENT AND RELEASE OF LIABILITY

The City of Prineville (City) may deny any application that does not, in the sole discretion of the City of Prineville, meet all of the eligibility requirements of this rebate program. Rebates are distributed on a first-come first-served basis until all funds are distributed and the City reserves the right to change or end this program at any time. The City does not guarantee that participating in this rebate program will result in lower water bills, and is not responsible for damage that may occur to the applicant's property or irrigation system as a result of installing the new irrigation hardware purchased through this program. The City does not provide a warranty on any component of the hardware, nor does it warrant, endorse, or assume liability for the quality or performance of the installed equipment purchased under this program. The City reserves the right to enter the property, with notification, to inspect and approve the installation of the hardware for conformity to program requirements prior to issuing the rebate. To qualify for a rebate, you must submit this rebate form within 30 days of the purchase of your irrigation hardware, which must be installed at the residence identified on the application. The total rebate amount will not exceed the receipt amount. The rebate will be applied as a credit to your water account; a check will not be distributed.
